inherent risks including, but not limited to the risk of personal injury, including catastrophic injury, or death, or property damage, which may be caused by variations in terrain or weather conditions; or, surface or subsurface snow, ice, bare spots or areas of thin cover, moguls, ruts, bumps; or other persons using the facilities; or, rocks, forest growth, debris,

Downhill skiing and snowboarding, like many other sports, contains facility in New York State. New York law imposes a duty on you to become apprised of, and understand, the risks inherent in the sport of skiing, as set forth by New York State, so that you may make an informed decision of whether to participate in skiing notwithstanding the risks. New York law also imposes additional duties upon you, to which you must adhere, for the purpose of avoiding injury caused by any of the risks inherent

in skiing. If you are not willing to assume all of these risks and abide by branches, trees, roots, stumps; or, other natural objects or manmade objects that are incidental to the provision or maintenance of a ski all of these duties, you must not participate in skiing at these ski areas.



- 1. "Family members" include head of household and/or spouse and "dependent" persons under 21 (born on or after 11/1/01) who are living at home or attending college full time. "Dependent" persons are those claimed on your federal tax return for year 2022.
- 2. "Dependent" children born on or after 11/1/16 are entitled to a FREE pass when parent(s) purchase(s) a full season pass. If parent(s) purchase(s) their pass(s) by October 7, 2022, child can optionally receive a 'Tot' ski package (skis, boots, and poles) for their exclusive use for the 2022-23 season, WHILE SUPPLIES LAST. An "Equipment Loan" agreement, a \$149 processing charge, and a \$99 refundable security deposit are required.
- 3. Proof of identification and age is required of all applicants.
- 4. Payments must be made on or before the due date by check, credit card or cash. Payment may be made to Song Mountain by mail (E-mail or USPS), by phone, by fax, or in person. If by mail, postmark (or time stamp for E-mail) must be on or before the due date. If due date is missed, the next higher rate will apply.
- 5. Song Mountain Thunderbird Club members also receive unrestricted lift privileges at Labrador Mountain.
- 6. A"Non-Skiing" Thunderbird membership is for family members who DO NOT wish to have lift privileges. It is NOT available

to anyone holding a non-Tbird season pass.

- 7. Thunderbird membership includes one 15" locker per family. Additional 15" lockers, 18" lockers, and sloped top (taller) lockers are available on a 1st paid, 1st served basis at a rate of \$175, \$100, and \$75 respectively. Prices shown DO NOT include 8% sales tax (I Looooooove NY).
- 8. There is a \$10 'card charge' per card issued for the life of that card. Renewing members will keep the same card(s) from year to year. Optionally, for each extra ACTIVE card issued per family, there is an additional \$25 'second vehicle charge' per season. In other words, you pay the \$10 'card charge' once per card for the life of the card. Optionally, you pay the \$25 'second vehicle charge' each season.
- 9. A contribution to the Ski Patrol Endowment Fund is encouraged but is 100% VOLUNTARY. Any amount will be accepted but \$10 for individuals and \$20 for families is recommended. All amounts collected will be utilized by the Ski Patrol to update equipment and enhance their ability to serve the skiing and snowboarding public. Song Mountain retains no portion of this contribution.
- 10."Social Dues" are mandated by the Thunderbird Club Board of Directors, \$75 for the first individual, and \$45 for each additional person in your family. Song Mountain does not retain any portion of these dues. No passes will be issued until dues are paid.

Season passes must be worn above the waist so that they remain easily visible at all times. The operation of Song & Labrador Mountains are at the sole discretion of management and may be dictated by weather, snow conditions, safety concerns, and many other uncontrollable variables. Lost or stolen passes should be reported immediately. There is a \$25 charge for replacement of lost or stolen passes. Do not forget your pass! Day lift tickets will be issued in lieu of forgotten passes as follows: first time = \$5, 2nd time = \$25, 3rd time or more = full ticket price. Passes remain the property of Song & Labrador Mountains and are strictly nontransferable. Passes will be revoked without refund if transferred or otherwise misused.
