WARNING TO SKIERS AND SNOWBOARDERS

Downhill skiing and snowboarding, like many other sports, contains inherent risks including, but not limited to the risk of personal injury, including catastrophic injury, or death, or property damage, which may be caused by variations in terrain or weather conditions; or, surface or subsurface snow, ice, bare spots or areas of thin cover, moguls, ruts, bumps; or other persons using the facilities; or, rocks, forest growth, debris, branches, trees, roots, stumps; or, other natural objects or manmade objects that are incidental to the provision or maintenance of a ski



facility in New York State. New York law imposes a duty on you to become apprised of, and understand, the risks inherent in the sport of skiing, as set forth by New York State, so that you may make an informed decision of whether to participate in skiing notwithstanding the risks. New York law also imposes additional duties upon you, to which you must adhere, for the purpose of avoiding injury caused by any of the risks inherent in skiing. If you are not willing to assume all of these risks and abide by all of these duties, you must not participate in skiing at these ski areas.

Notes, Terms And Conditions

1. “Family members” include head of household, spouse and “dependent” persons under 21 (born on or after 11/1/03) who are living at home or attending college full time. “Dependent” persons are those claimed on your federal tax return for 2024.
2. “Dependent” children born on or after 11/1/18 are entitled to a FREE pass when parent(s) purchase(s) a full season pass. If parent(s) purchase(s) their pass(s) by October 14, 2024, child can optionally receive a ‘Tot’ ski package (skis, boots, and poles) for their exclusive use for the 2024-25 season, **WHILE SUPPLIES LAST**. An “Equipment Loan” agreement, a \$159 processing charge, and a \$99 refundable security deposit is required.
3. “Seniors” are born on or before 11/1/59.
4. “Super Seniors” are born on or before 11/1/44.
5. “Students” are born on or after 11/1/03.
6. “Full Time College” students, born on or after 11/1/99, are entitled to the “College” rate. Proof of full time status will require a photo college ID **AND** a letter from the Registrar (or enrollment certification from the National Student Clearinghouse, www.studentclearinghouse.org). Both ID and verification must be shown prior to issuance of pass.
7. “Sat or Sun” passes are good EITHER Sat or Sun all season (9 am - till) and are mountain specific. You must choose specific day and specific mountain prior to first use.
8. “Shift” passes are good at either Song Mountain or Labrador Mountain for one 8 hour lift ticket per week, Mon through Fri, or Sat from 4pm till closing, for the entire season. No makeups for missed weeks.
9. “Senior”, “Super Sr”, “Student”, “College”, “Sat or Sun”, and “Shift” passes are sold on an individual basis ONLY.
10. Proof of identification and age is required of all applicants.
11. Payments must be made on or before the due date by check, credit card or cash. Payment may be made by mail (E-mail or USPS), by phone, by fax, or in person. If by mail, postmark (or time stamp for E-mail) must be on or before the due date. If due date is missed, the next higher rate will automatically apply.
12. Lockers are sold on a first come, first served basis. Varying widths are available but all are 72” tall. For skis longer than 190 cm, add \$50 for a slope topped (tall) locker. Prices shown **DO NOT** include 8% sales tax.
13. A contribution to the “Ski Patrol Endowment Fund” is **100% VOLUNTARY**. They will accept any amount but \$10 for individuals and \$20 for families is recommended. These guys and gals do a *Tony The Tiger* GRRRREAT job! All funds collected go to update Ski Patrol equipment enhancing their ability to serve the skiing and snowboarding public. Song Mountain or Labrador Mountain do not retain any of these contributions.

Season passes must be worn above the waist so that they remain easily visible at all times. The operation of Song & Labrador Mountains are at the sole discretion of management and may be dictated by weather, snow conditions, safety concerns, and many other uncontrollable variables. Lost or stolen passes should be reported immediately. There is a \$25 charge for replacement of lost or stolen passes. **Do not forget your pass!** Day lift tickets will be issued in lieu of forgotten passes as follows: first time = \$5, 2nd time = \$25, 3rd time or more = full ticket price. Passes remain the property of Song & Labrador Mountains and are strictly nontransferable. Passes will be revoked without refund if transferred or otherwise misused.

NO REFUNDS for season passes will be issued FOR ANY REASON.
